



HORSE SHOWS IN THE PARK, LLC VENDOR APPLICATION

TERMS AND CONDITIONS

The policy of the horse show is to accept Vendors as space permits, while potentially limiting the number of Vendors with similar wares. Horse Shows in the Park, LLC (HSITP) reserves the right to reject any application for any reason. No specific vendor location is guaranteed.

Note: The following are vendor charges levied by each venue:

Canterbury: \$35.00 per day paid directly to Canterbury / Wendy Low
Jacksonville: \$75.00 per weekend paid to Horse Shows in the Park, LLC
Rose Dhu: none at this time
Weirsdale: \$25 per weekend paid to Horse Shows in the Park, LLC
Wickham: none at this time

In addition, in exchange for the opportunity to offer/sell product and/or services, Horse Shows in the Park, LLC requires a \$25.00 gift certificate for such services and/or product per show weekend to be provided by the vendor, for purposes of award at the show. This certificate must be provided to the show office for display and announcement no later than the start of scheduled classes on Saturday.

All vendors are responsible for complying with all applicable sales tax requirements. Horse Shows in the Park, LLC assumes no responsibility in this regard.

All signage and/or banners must be maintained in the area assigned and may not disrupt the show rings in any way.

No weaponry, knives or any other item is allowed on the showgrounds which may be construed by show management as a potential danger to an exhibitor, spectator or animal.

Vendors must adhere to all direction provided by facility management and/or the designated Show Manager in relation to location, logistics and / or behavior. Lack of adherence to such direction will result in immediate dismissal from the showgrounds with no refund of vendor fees.
