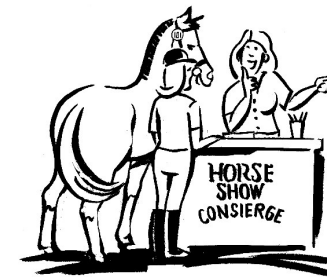

Novice Rider—any age—Rider not to have jumped over 2'6" at a show. Fences will be simple verticals over flower boxes set to 18", no oxers.

GENERAL INFORMATION

- Entry fees are \$12.00 per class for pre-entries received prior to 8pm on Tuesday before show. \$10.00 late fee applies after Tuesday at 8:00pm. Office/Insurance per rider \$15.00. \$5.00 mbership fee. Marshall & Sterling classes are \$25.00. No schooling, grounds or trailer in fees (Brevard 4-H entries \$9.00 per class, \$5.00 office/insurance fee/must pre-enter or no discount-will be verified). All entries will be charged a minimum of 1 class. Trailer in at no charge, or Stalls \$30. Reserve stalls on entry, supply your own bedding, leave clean or \$10 stall cleaning charge. No numbers issued until a signed entry blank has been received and the secretary has received an open check. **No Medic Present. Current Negative Coggins req'd.**
- Paddock Master will limit # of riders and time in schooling. You must have a current show number to school.
- Payment: VISA/MasterCard accepted with \$10 ETF fee. NSF fee \$50.00.
- Schooling fences may be set in smaller arena
- Show management reserves the right to refuse entry, combine or cancel classes for any reason.
- All dogs must be on leash. !
- **Boots, breeches, polo shirts.** USEF/ASTM approved headgear required for all mounted participants
- Walk-Trot riders not to have cantered in a show. Beginner Walk Trot riders may cross enter Crossrails Hunter and trot the course.
- 3 minute gate call strictly enforced. Advise Announcer of any conflict.

THIS DOCUMENT WAIVES IMPORTANT LEGAL RIGHTS. READ IT CAREFULLY BEFORE SIGNING

By entering a Horse Shows in the Park, LLC. recognized Competition, and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Trainer, Rider or Handler and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Constitution and Rules of Horse Shows in the Park, LLC and the local rules of the competition. I agree to be bound by the Constitution and Rules of Horse Shows in the Park, LLC and of the competition. I will accept as final the decision of the officers of Horse Shows in the Park, LLC on any question arising under the Rules, and agree to release and hold harmless the competition, Horse Shows in the Park, LLC, their officials, directors, and employees or volunteers for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, Horse Shows in the Park, LLC and/or the Competition may use or assign photographs, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or Horse Shows in the Park, LLC. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of the Horse Shows in the Park, LLC rules are governed by the laws of the State of Florida and any action instituted against the Horse Shows in the Park, LLC must be filed in Florida.

HORSE SHOWS IN THE PARK, LLC RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION

I AGREE, in consideration for my participation in the Competition to the following:
I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owner, agent, coach/trainer or as a parent or guardian of a junior exhibitor, I am fully aware and acknowledge that horse sports and the Competition involves inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (Harm*).
I AGREE to release the Horse Shows in the Park, LLC., Jeanne and Page Winslow and the Competition from all claims for money damages of otherwise for any Harm to my horse or me and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Horse Shows in the Park, LLC, it's officers/directors, or the Competition.
I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Horse Shows in the Park, LLC or the Competition.
I AGREE to indemnify (pay any losses, damages, or costs incurred by) Horse Shows in the Park, LLC. and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.
I have read the Horse Shows in the Park, LLC and Competition rules about protective equipment and I understand that I am entitle to wear protective equipment without penalty and I acknowledge that the Horse Shows in the Park, LLC Inc. strongly encourages me that I do so.
